IDENTITY THEFT

A QUICK REFERENCE GUIDE

18 Pa. C.S. 4120: Identity Theft

(a) A person commits the crime of identity theft of another person if he possesses or uses, through any means, identifying information of another person without the consent of that other person to further any unlawful purpose.

Make a note of this case number in your detailed history folder and reference it when you have contact with any business or law enforcement agency concerning this report. Depending upon the location (jurisdiction) of where the crime occurred (goods or services obtained or delivered), an investigator may or may not be assigned to this case.

If the crime occurred in our jurisdiction and there are workable leads, such as witness and suspect information, an investigator will be assigned to the case. Unfortunately not all cases will be assigned to an investigator because there are no significant leads to identify the suspect.

If a crime occurred outside of our jurisdiction, we will attempt to contact the appropriate law enforcement agency for further investigation.

If you are a victim of identity theft, contact the Federal Trade Commission (FTC) to report the problem. The FTC is a federal clearinghouse for complaints by victims of identity theft. The FTC helps victims by providing information to help resolve financial and other problems that could result from identity theft.

Call each of the three credit bureau fraud units to report identity theft. Ask to have a "Fraud Alert/Victim Impact" statement placed in your credit file asking that creditors call you before opening any new accounts.

Request that a copy of your credit report be sent to you.

The attached "Course of Action" chart is helpful for reporting identity theft. Make sure to keep an accurate log of the agency, date contacted and the person contacted when reporting the fraudulent use of your identity.
